Home & Everyday

Legal issues and disputes in connection with renting or owning property, everyday transactions (e.g. purchases), and breaches of personal privacy.

Optional: supplementary coverage for landlords/landladies

Legal issues and disputes in your capacity as a landlord or landlady.

The following are examples of the types of disputes the policy covers:

- ✓ Disputes with landlords/landladies, other tenants
- ✓ Disputes with neighbors
- ✓ Disputes concerning purchases made online
- ✓ Disputes concerning cell phone contracts, gym memberships, and other contracts
- ✓ Infringements of privacy



Mobility & Travel

Legal issues and disputes in connection with vehicles, traffic violations, and travel contracts.

The following are examples of the types of disputes the policy covers:

- ✓ Road traffic disputes
- ✓ Disputes concerning vehicles (purchase, repair, rental)
- ✓ Disputes while traveling



Health & Personal Insurance

Legal issues and disputes in connection with an impairment of your health and in cases of maternity, retirement, or unemployment.

The following are examples of the types of disputes the policy covers:

- ✓ Disputes with insurance companies and doctors
- ✓ Disputes concerning injuries resulting from traffic accidents, accidents at work, or other accidents
- ✓ Disputes regarding maternity pay
- ✓ Disputes with your pension fund
- ✓ Disputes with the unemployment insurance fund
- ✓ Disputes with the adult protection authority (KESB)



Work

Legal issues in connection with your employment and disputes with your employer.

Optional: supplementary coverage for management functions

Legal issues and disputes in your capacity as an executive board member.

The following are examples of the types of disputes the policy covers:

- ✓ Disputes with employers
- ✓ Disputes as a self-employed person (annual turnover of up to CHF 36,000)
- ✓ Disputes regarding salary
- ✓ Disputes regarding work references

Taxes

Legal issues and disputes with the Swiss tax authorities regarding income tax and wealth tax
